## 11 Catalina – Delete 11.1 and 11.2 and replace with:

11.1 Mark 1 – Leave Catalina Island to port

## 12.3 Add:

San Clemente Island has virtual military exclusion zones meant to be safety zones around sections of the island. The "SHOBA" (Military acronym for something) zone is shown in Addendum A.4 in purple. The bottom of the zone is defined by a line btw virtual point SHOBA 3 (32 45.0n, 118 34.9w) and SHOBA 2 (32 45.0n, 118 15.0w). It is a continuing obstruction. All boats shall stay south of this line.

## 13.2 Delete and replace with:

13.2 A boat's YB Tracker will transmit the boat's position every 60 minutes in real time from the start, until boats are at the dock in San Diego. The YB Tracker will also transmit a lat/lon and PST time when it crosses the virtual finish line in SI 11.1. This data will be used to determine a boat's finish time. [NP/DP]
