Notice of Race

Albatross Yacht Club, Mt Clemens, MI, USA, is the organizing authority and will provide race management.

1. Rules

- 1.1. This race will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS) and as modified by the *Anchor Bay Yacht Racing Association 2021 Racing Handbook* (ABYRA Handbook), this Notice of Race, and the sailing instructions for this race. The ABYRA Handbook is available on the Albatross Yacht Club website www.sailayc.org/racing and NSSC website NorthStarSail.org/Racing

2. Eligibility and Entry

- 2.1. This race is open to sail yachts owned or chartered by individual members of clubs or associations that are members in good standing of ABYRA, DRYA, or US Sailing, and who have paid their race fees.
- 2.2. This race is open to JAM, asymmetrical, and spinnaker classes. Class splits will be posted at NSSC clubhouse no later than 2 hours before the race. Five boats are required for a class.
- 2.3. Registration shall be submitted according to registration instructions on YachtScoring.com
Completed entry forms shall be received by 1900 on the day prior to the event.
- 2.4. Late entries will be accepted and will be subject to a \$5.00 late fee.

3. Fees

- 3.1. The fee for this race is \$40

4. Schedule

- 4.1. The race is scheduled for June 26, 2021.
- 4.2. The warning signal for the first start is scheduled for 1900.

5. Measurement

- 5.1. If a boat does not have a current DRYA rating certificate, the RC will assign a temporary rating as described in the ABYRA Handbook.

6. Sailing Instructions

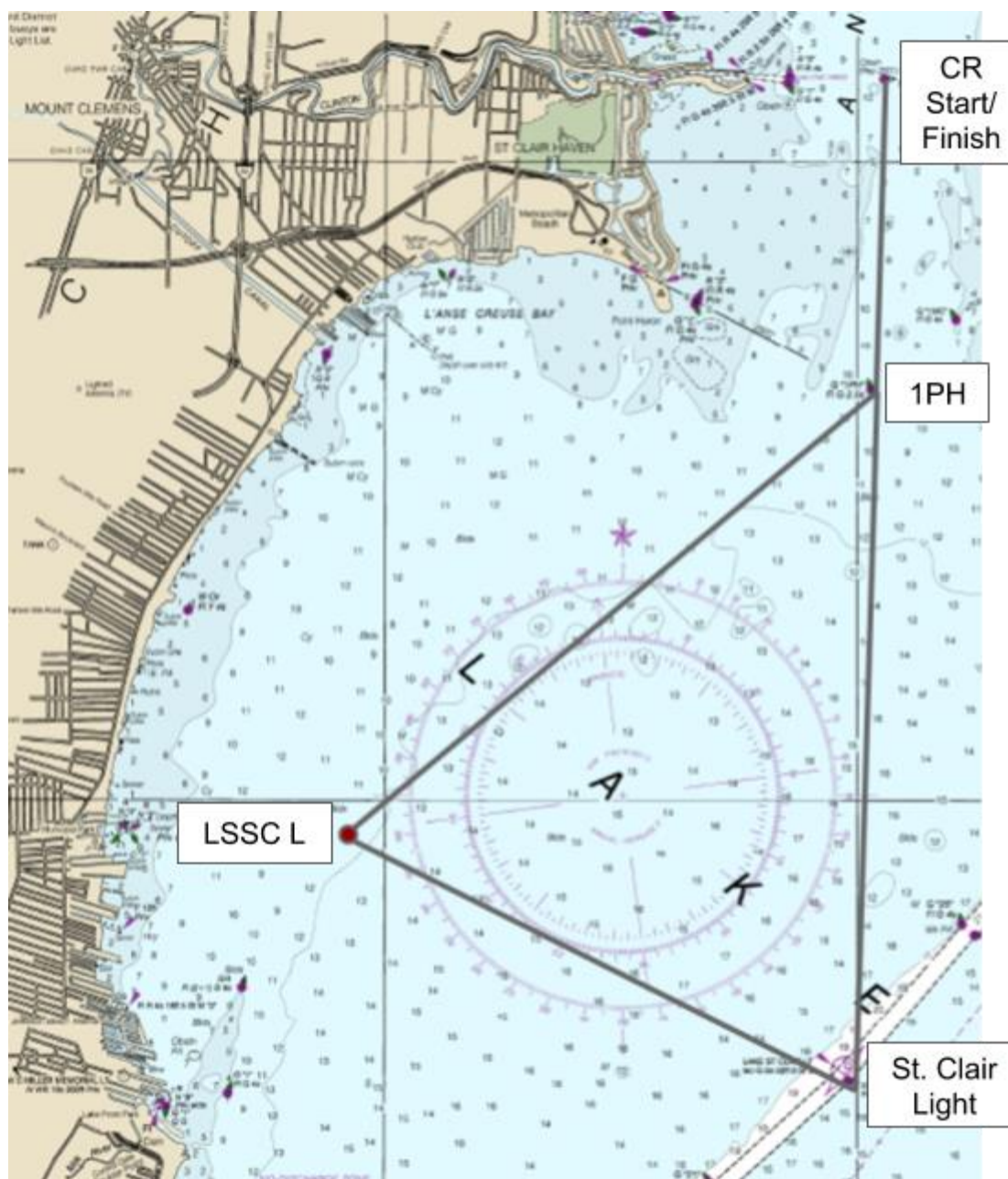
6.1. Sailing instructions will be posted on YachtScoring.com no later than one week prior to the event.

7. Venue

7.1. The venue will be the US waters of Lake St. Clair

8. Courses

8.1. One of two courses on Lake St. Clair will be used. Approximate course and mark locations are illustrated below.



8.2. **Green Course:** Start–1PH–St.Clair Light–LSSC L–1PH–Finish

8.3. **Red Course:** Start–1PH–LSSC L–St.Clair Light–1PH–Finish

8.4. Course selection will be visually communicated to competitors prior to the warning signal.

8.5. Approximate mark positions:

CR	42° 35.57' N, 82° 44.51' W
1PH	42° 32.79' N, 82° 44.78' W
St. Clair Light	42° 27.93' N, 82° 45.24' W
LSSC Buoy L	42° 29.81' N, 82° 50.62' W

8. Scoring

8.1. Races will be scored using time-on-time over PHRF for classes and division overall.

9. Awards

9.1. Pending the Michigan COVID protocols in place at the time, a Post Race picnic will be held the following day at North Star Sail Club between 1200 and 1500 hrs. Awards will be made at that time. If a gathering is not possible, the organizing club will deliver the awards to the winners.

10. Disclaimer of Liability

10.1. Competitors participate in the race entirely at their own risk. See RRS 3, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the race.

11. Insurance

11.1. Each participating boat shall be insured with valid third-party liability insurance.
