

Official changes to the Sailing Instructions for the Cape to Cape Challenge Cup VII dated and posted July 29, 2015. Changes Posted 7/30/15 at 1400 Hours.

- **Change 1: Section 9: Bullet seven:**
- Course A all fleets shall approach the finish area off the Lewes Yacht Club by taking the Harbor of Refuge light at W38° 48.9' W75° 05.5' to Starboard and Cape Henlopen to Port.
- **Is deleted and replaced with:**
- **Course A all fleets shall approach the finish area off the Lewes Yacht Club by taking the Harbor of Refuge light at W38° 48.9' W75° 05.5' to Starboard and Cape Henlopen to Port. Finish line will be located near N 38° 47.782 by W 75° 08.603'.**

Change 2: Section 10 Marks

- **Add:**
- **For course changes on Friday July 31 buoy races, the marks changed will be yellow tetrahedrons.**

Change 3: Section 15 the Finish:

- The finishing line will be between a staff displaying an orange flag on a Race Committee boat and an orange tetrahedron at the finishing line location provided in items 8 and 9 “The Courses”.
- **Is deleted and replaced with:**
- **The finishing line for the bouy races on July 31 will be between a staff displaying an orange flag on a Race Committee boat and weather mark at the finishing line location provided in section 8. The finish line for the race on Aug 1, shall be between a LYC club boat with staff displaying an orange flag and a red ball located off LYC near**
 - **N 38° 47.782 by W 75° 08.603'.**

Change 4: Section 18 Protests Bullets 3 and 4

- Protests shall be written on USSA forms available from the Lewes Yacht Club and lodged with the Protest Committee there within the Protest Time which will begin at the time of the docking of the Race Committee Finish boat and end 45 minutes later. Docking time will be posted on the Official Notice Board located at the Lewes Yacht club.
- Protest notices will be posted at the Lewes Yacht Club within one-half hours of the Protest Time limit to inform competitors where and when there is a hearing in which they are interested parties or witnesses.
- **Are deleted and replaced with:**
- **Protests shall be written on USSA forms available from LYC or CYCCM**

and lodged the day of the race with the Protest Committee there within the Protest Time which will begin at the time of the docking of the Race Committee Finish boat and end 45 minutes later. Docking time will be posted on the Official Notice Board located at LYC and CYCCM.

- **Protest notices will be posted at LYC and CYCCM within one-half hours of the Protest Time limit to inform competitors where and when there is a hearing in which they are interested parties or witnesses.**
