

Etchells Saida Cup

2nd & 3rd July 2022





Royal Thames Yacht Club - Cowes Etchells Fleet Cowes, Isle of Wight

The Organizing Authority (OA) is the RTYC Regattas Limited in conjunction with the Cowes Etchells Fleet.

The notation [DP] in a rule means that the penalty for a breach of the rule may, at the discretion of the protest committee, be less than disqualification.

1. RULES

The event will be governed by the rules as defined in The Racing Rules of Sailing.

2. CHANGES TO SAILING INSTRUCTIONS

Any change to the sailing instructions will be posted before 0900 on the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.

3. COMMUNICATION WITH COMPETITORS

- 3.1. Notices to competitors will be posted on the official notice board located at www.yachtscoring.com. The race committee will use the Etchells Saida Cup event WhatsApp group to alert competitors when there has been a posting.
- 3.2. The race office is located at Cowes Yacht Haven, telephone +44 7898685232 email jenn.lancaster@royalthames.com.
- 3.3. On the water, the race committee intends to monitor and communicate with competitors on VHF radio channel 06.
- 3.4. The following communications may be made by the race committee on VHF radio: location of race committee vessel, alternate preparatory signals, courses, postponement, abandonment, starting signals, recalls.
- 3.5. [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
- 3.6. [DP] Boats may be supplied a tracker by the OA. The tracker shall be carried onboard when leaving its berth until it has returned ashore. Trackers shall be collected from and returned to the Etchells container at Cowes Yacht Haven. Trackers shall be returned within the protest time limit.

4. CODE OF CONDUCT

[DP] Competitors and support persons shall comply with reasonable requests from race officials.

5. SIGNALS MADE ASHORE

No signals will be displayed ashore. The race committee will use the Etchells Saida Cup event WhatsApp group to keep competitors informed whilst ashore.

6. SCHEDULE OF RACES

6.1. Six (6) races are scheduled. A maximum of four (4) races per day may be sailed.

7. CLASS FLAG

The class flag for the Etchells Class will be code flag 'E'.

8. RACING AREA

The location of the start line will be announced via the event WhatsApp group by 0900 each race day.

9. COURSES

- 9.1. The diagrams in SI Addendum A show the course(s), including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be rounded.
- 9.2. No later than the warning signal, the race committee signal vessel will display the course signal and the approximate compass bearing of the first leg.
- 9.3. If either gate mark 4s or 4p is missing, boats shall round the remaining gate mark to port.

10. MARKS

- 10.1. Marks 1, 1a, 4s and 4p will be orange inflatable buoys.
- 10.2. The start and finish marks will be a RTYC dan buoy.
- 10.3. A new mark, as provided by SI 13 will be a black inflatable buoy.

11. OBSTRUCTIONS

The Moving Prohibited Zone (MPZ), as detailed by the Associated British Ports of Southampton – Notice to Mariners No 08 of 2022, is designated as an obstruction. 12. THE START

- 12.1. Races will be started using RRS 26 with the warning signal made five (5) minutes before the starting signal.
- 12.2. To alert boats that a race will begin soon, the orange starting line flag will be displayed with multiple sound signals not less than five (5) minutes before a warning signal is displayed.
- 12.3. The starting line is between a staff displaying an orange flag on the committee vessel at the starboard-end and the course side of the port-end starting mark.
- 12.4. In addition to RRS 29.1, if any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee will attempt to hail her bow or sail number on VHF radio. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a redress request. This changes RRS 62.1(a).
- 12.5. A boat that does not start within 4 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.

13. CHANGE OF THE NEXT LET OF THE COURSE

- 13.1. To change the next leg of the course, the race committee will lay a new mark (or move the finish line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.
- 13.2. The race committee may change a leg of the course by up to ten (10) degrees in bearing and/or 200m in length without a signal. This changes RRS 33.

14. THE FINISH

The finishing line is between a staff displaying a blue flag on the committee vessel at the starboard-end and the course side of the port-end finishing mark.

15. PENALTY SYSTEM

- 15.1. A boat may take a One-Turn Penalty when she may have broken a rule of Part 2 or rule 31 while racing. However, when a boat may have broken a rule of Part 2 while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty. This changes RRS 44.1.
- 15.2. In RRS 44.2 insert after the first sentence: "However, if Mark 1a (spreader mark) is set, a boat may take a penalty for an incident in the zone around Mark 1 or on the leg between Mark 1 and Mark 1a, as soon as possible after leaving the zone around Mark 1a."

16. TIME LIMIT

- 16.1. The time limit for each for race will be 90 minutes.
- 16.2. Finish Window: The time for boats to finish after the first boat sails the course and finishes is 20 minutes.
- 16.3. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized or given redress, will be scored Time Limit Expired (TLE) without a hearing. A boat scored TLE shall be scored points for the finishing place 2 (two) more than the points scored by the last boat that finished within the Finishing Window. This changes RRS 35, A5.1, A5.2 and A10.

17. HEARING REQUESTS

- 17.1. The protest time limit is 90 minutes after the last boat finishes the last race of the day or the race committee signals no more racing today, whichever is later. The time will be posted on the online official notice board.
- 17.2. Hearing forms are available from the race office at Cowes Yacht Haven.
- 17.3. Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held virtually via Microsoft Teams.

18. SCORING

- 18.1. One (1) race is required to constitute a series.
- 18.2. When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.
- 18.3. When five (5) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

19. SAFETY REGULATIONS

- 19.1. [DP] Before the first warning signal for the first race each day, each boat shall: 1) sail past the race committee signal vessel on starboard tack; 2) announce her bow number; and 3) obtain the recognition of her bow number by the race committee.
- 19.2. [DP] A boat that retires from a race shall notify the race committee via VHF before leaving the course, or, when that is impossible, immediately after arrival ashore by contacting the race committee via the event WhatsApp Group.

20. REPLACEMENT OF CREW OR EQUIPMENT

- 20.1. [DP] Substitution of competitors is not allowed without prior written approval of the OA.
- 20.2. [DP] Substitution of damaged or lost equipment is not allowed unless authorized in writing by the race committee. Requests for substitution shall be made to the committee at the first reasonable opportunity, which may be after the race.

21. EQUIPMENT AND MEASUREMENT CHECKS

A boat or equipment may be inspected at any time for compliance with the class rules, notice of race and sailing instructions.

22. SUPPLIED BOATS

23. OFFICIAL VESSELS

- 23.1. The Race Committee signal vessel will be the M/V Kittiwake.
- 23.2. Mark laying vessels will be RIBs flying RTYC burgees.

24. SUPPORT PERSON VESSELS

- 24.1. The race committee would like to call special attention to RRS 37.
- 24.2. All support vessels shall carry a marine VHF radio capable of receiving and transmitting on all international channels.
- 24.3. [DP] All support vessels shall stay at least 200m outside the areas where boats are racing from the time of the first warning signal of the day until racing has concluded for the day.
- 24.4. [DP] Between races, no support person shall approach, communicate with or transfer provisions or equipment to or from any competitor unless it is an emergency threatening the health of the crew or flotation of a boat and only with the expressed permission of the race committee.

25. TRASH DISPOSAL

Trash may be placed on official vessels.

26. BERTHING

Berthing is the responsibility of each competing boat.

27. HAUL-OUT RESTRICTIONS

- 27.1. All boats shall be afloat no later than 1800 the day before the first scheduled race.
- 27.2. Boats shall not be hauled out during the event except with and according to the terms of prior written permission of the race committee.

28. DIVING EQUIPMENT AND PLASTIC POOLS

- 28.1. No person shall swim or undertake any underwater or diving activities of any kind within Cowes Harbour without permission and/or a permit from the Cowes Harbour Master or the authorized marina manager. See: Cowes Harbour Commission General Direction 4.4 and 4.5.
- 28.2. Underwater breathing apparatus and plastic pools or their equivalent shall not be used around competing boats from 1800 on the day before the first scheduled race until the end of the event.
- 28.3. Competing boats shall not be cleaned more than 10cm below the waterline by any means from the preparatory signal of the first race until the end of the event.

29. PRIZES

Prizes will be awarded as soon as possible after racing on Sunday 3 July 2022 at Cowes Yacht Haven to the following boats:

- a. The Royal Thames Yacht Club Saida Cup, a perpetual trophy, will be awarded to the winner of the regatta at the annual RTYC Prize Winners' Dinner. Invitation to follow.
- b. Prizes for the top three (3) boats.
- c. The Corinthian Prize will be awarded to the highest placed boat sailed by a WS Category 1 crew.

30. RISK STATEMENT

RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:


- a. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
- b. They are responsible for the safety of themselves, their crew, their boat, and their other property whether afloat or ashore.
- c. They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions.
- d. Their boat is in good order, equipped to sail in the event and they are fit to participate.
- e. The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.
- f. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- g. It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

31. INSURANCE


Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

Course Illustrations - Windward Leeward




