NOTICE OF RACE

1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.

2 SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be available on the Event's Yacht Scoring website <https://yachtscoring.com/> no later than the Thursday July 7th at 1800 hrs.

3 COMMUNICATION

- 3.1 The online official notice board is located at the Yacht Scoring website noted above.
- 3.2 All PHRF Class boats shall carry a VHF radio capable of communicating on channels 16 and 72 as well as receiving weather forecasts. The race committee may communicate with competitors on Channel 72; however, failure of the race committee to transmit or failure of a boat to receive transmission shall not be grounds for redress. Should there be conflict with other sailing organization events in the area, race committee may select from channels 69, 70, 71 or 72.
- 3.3 From the first warning signal until the end of that race, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all other boats in their class.

4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to any self-righting sailboat with an enclosed cabin, must have self-draining cockpit and a current WF PHRF rating for a Class 4 race and One Design Sailfish Class. See www.westfloridaphrf.org.
- 4.2 There must be a minimum of three (3) boats in each class registered for the July 8th races by July 7th at 1800 hrs. to be eligible for a race in that class on July 8th.
- 4.3 Eligible boats may enter by completing the entry form at the Yacht Scoring website noted above. Entries are not complete until payment, online waiver and insurance details have been completed.
- 4.4 A boat must declare in writing her intent to use an asymmetrical spinnaker by Thursday July 7th 1800 hrs. for the July 8th race.
- 4.5 Skipper and crew must register their individual personal information and acknowledge the waiver in the Event registration within Yacht Scoring website as noted above.
- 4.6 Same day late entries will not be accepted
- 4.7 The boat must be owned by a member in good standing of a recognized yacht club, sailing club or like organization.

6 SCHEDULE

6.1 Registration: by Thursday July 7th 2022, 1800 hrs. Late fees apply.

6.2 Following each race date's completed race, there will be a post-race social on the west side of the Dunedin Boat Club – Clubhouse with bites and beverages for competitors and their crew.

7 VENUE

7.1 The racing area will be St. Joseph Sound directly in front of the Dunedin Boat Club's Clubhouse floating dock located on the west side of the Clubhouse.

7.2 The floating dock will be referred to as the Signal. The Start/Finish will be directly west of the floating dock near the clubhouse with the racing area north of there and east of the ICW. Race committee flags will be displayed at the floating dock and on designated support boats if used.

8 COURSE

8.1 The course to be sailed will be more fully described in the Sailing Instructions.

9 PROTEST

9.1 Protest should be resolved on the water. In the event of a bodily injury or material damage, a formal protest should be filed. The Race Committee must be notified of protest by the end of the race. The parties involved will be notified as to when a hearing will take place. Protest forms are located on Yacht Scoring.

10 SCORING

10.1 Scoring will be managed on Yacht Scoring.

10.2 Participation in 3 of 4 races is required to qualify for an award. If a competitor participates in all 4 dates, their worst days score will be thrown out.

10.2 The Course will use the RLC rating from their PHRF Certificate.

11 SUPPORT PERSON VESSELS

11.1 Support vessels if used shall be marked with a blue flag.

12 RISK STATEMENT

- 12.1 RRS 3 states: The responsibility for a boat's decision to participate in a race or to continue to race is hers alone. By participating in this event each competitor agrees and acknowledges that the sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia and other causes.
- 12.2 Competitor/Skipper is liable for the safety and behavior of their crew. Competitors will abide by all the rules, regulations and documents that will govern this Regatta including any safety related measures required by any State emergency order(s) issued because of any health orders by Federal, State and Local Government. Competitors, voluntarily assume the risks associated with communicable diseases including but not limited to COVID-19. - 13.1 Each participating boat is to be insured with a valid third-party liability insurance. The name of the keel Boat's insurance carrier and the keel Boats insurance policy number will be required with registration. The sunfish boat skippers need to report which Organizing Authority Club they are members in good standing of,

- 14.1 Prizes for the SERIES overall finishes will be awarded for 1st, 2nd and 3rd place during the Dunedin Boat Club General Meeting that follows the last race date or a General Membership meeting close by.
