NoR 7 Schedule is amended to remove the in-person registration periods on Friday and Saturday, August 25<sup>th</sup> and 26<sup>th</sup> and the competitors meeting on the 25<sup>th</sup>.

Add to NoR 7 Schedule: Dragon Force 65 Racing on Saturday, August 26<sup>th</sup> with a first warning at 1700 and maximum of 6 races.

If the OA does not accept those entry of the class, the Organizing Authority will notify the registered boats and refund their fees."

- 4.5 J/24 District 15 RACERS
  - (a) District 15 Championship will be held in conjunction with the Chicago Inshore Verve. Hosted by Fleet #100 Wilmette IL (This event will award one World's Birth to the top place District 15 Boat)
  - (b) Proof of J/24 Class Association for the boat owner and the driver required.
- 4.6 J/24 EQUIPMENT INSPECTION Each J/24 boat shall submit the following documents either on Friday or Saturday, during registration hours:
  - (a) A valid, IJCA issued Measurement Certificate, Including Part C: Inventory of Required and Optional Equipment.
  - (b) Boats will be subject to inspection at any time and for any class rules during the event.
- 4.7 J/24 CREW All competitors shall be weighed during the Friday evening or Saturday morning on-site check-in hours. Each competitor must have a valid passport or other photo identification, that includes birthdate, at weigh-in.

In NoR 5.1 strike the words "Jib and Main" for the CYC Sonar class

**NoR 7.0** in Schedule is amended to reflect the correct regatta dates, which are Friday, August 25, 2023, Saturday, August 26, 2023, and Sunday, August 27, 2023. No other changes to the schedule are made.

#### **ABBREVIATIONS**

[NP] Rules that are not grounds for a protest or request for redress by a boat but may be protested by the Race Committee or Organizing Authority. This changes RRS 60.1(a).

- 1 RULES
- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Appendices T and V1 shall apply.
- 1.3 [DP] Boats shall not fly drones while racing or in the racing area.
- 1.4 The rules of the International Etchells Class, International J/70 Class, and the Shields Class shall apply for their respective entries.

#### 2 SAILING INSTRUCTIONS

## 3 COMMUNICATION

- 3.1 The online official notice board is located at https://yachtscoring.com/emenu.cfm?eid=15804
- 3.2 [DP] All boats shall carry a VHF radio capable of communicating on US Marine Frequencies. This changes International Etchells Class Rules C.5.2(b) and Shields Class Rule Section IV-10.9.
- 3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be stated in the SIs.
- 3.4 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

- 4.1 This event is open to any one-design sailboats of 30 feet 6 inches LOA or shorter that is a member of a one-design racing fleet recognized by the Organizing Authority provided that at least four (4) boats in each respective class enter by 1800 on August 17 21, 2023.
- 4.2 If the minimum number of entries for a one-design class is not met, the Organizing Authority will notify the registered boats and refund their fees. If the minimum number of entries for a one-design class is not met by the entry deadline, the OA at its sole discretion may still accept entry of the class and the RC may combine starts for those classes. If the OA does not accept those entry of the class, the Organizing Authority will notify the registered boats and refund their fees.





- 4.3 Eligible boats may enter by completing the entry form and submitting it, together with the required fee, https://yachtscoring.com/emenu.cfm?eid=15804, by August 47 21, 2023.
- 4.4 For the J/70 Class: See Addendum 1 for additional Eligibility and Entry requirements.
- 4.5 J/24 District 15 RACERS:
  - (a) District 15 Championship will be held in conjunction with the Chicago Inshore Verve. Hosted by Fleet #100 Wilmette IL (This event will award one World's Birth to the top place District 15 Boat)
  - (b) Proof of J/24 Class Association for the boat owner and the driver required.
- 4.6 J/24 EQUIPMENT INSPECTION Each J/24 boat shall submit the following documents either on Friday or Saturday, during registration hours:
  - (a) A valid, IJCA issued Measurement Certificate, Including Part C: Inventory of Required and Optional Equipment.
  - (b) Boats will be subject to inspection at any time and for any class rules during the event.
- 4.7 J/24 CREW All competitors shall be weighed during the Friday evening or Saturday morning on-site check-in hours. Each competitor must have a valid passport or other photo identification, that includes birthdate, at weigh-in.

#### 8 VENUE

The races shall be sailed in the open waters of Lake Michigan east of Belmont Harbor.

#### 9 COURSES

The courses to be sailed will be windward leeward courses using drop or robotic marks.

- 10 SCORING
- 10.1 The scoring system is as follows: Low Point Scoring.
- 10.2 2 races are required to be completed to constitute a regatta.
- 10.3 A boat's total score will be the sum of her scores for all races. No score will be discarded. This changes RRS A2.

## 11 [DP] SUPPORT PERSON VESSELS

- 11.1 Support vessels shall register with the Regatta Manager prior to racing.
- 11.2 Support boats are responsible for making their own berthing arrangements, including trailer storage, with Chicago Harbors Belmont Harbor Authorities.
- 11.3 Launching and retrieval of support boats shall not impede the launching or retrieval of sailboats.

  Support boats should plan on using the ramp at Diversey Harbor instead of the cranes at Belmont Harbor.

#### 12 BERTHING

[DP] Boats shall be kept in their assigned places while in the harbor.

#### 13 HAUL-OUT RESTRICTIONS

[DP] Keelboats shall not be hauled out during the event except with, and according to the terms of, prior written permission of the race committee. Docking will be provided at CYC Belmont Station for competing boats only. Competitors requiring docking should contact <a href="mailto:dockmaster@chicagoyachtclub.org">dockmaster@chicagoyachtclub.org</a> prior to the event to request a reservation.

### 14 ENVIRONMENTAL

The Verve Cup Regatta is working with Sailors for the Sea Powered by Oceana to become a certified Clean Regatta. ## 15 RISK STATEMENT

Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. The organizing authority will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.





### 16 INSURANCE

Each participating boat shall be insured with a valid third-party liability insurance with a minimum cover of \$500,000 per incident or the equivalent. Competitors shall be prepared to supply proof of insurance upon request by the OA.

### 17 PRIZES

- 17.1 Prizes will be awarded by section for the top three finishers.
- 17.2 A prize will be awarded to the top placing Mixed+ J/70 team

## 18 PHOTOGRAPHY AND VIDEO RIGHTS

Competitors give absolute right and permission for any photographs or video footage taken of themselves or their competing boat to be published in any media whatsoever for editorial, commercial purposes, or to be used in press information.
