### 1. RULES

- 1.1 This Regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS). To the extent permitted by Part 7 of the RRS, specific provisions of the RRS may be modified, altered or made inoperative by the Notice of Race (NOR) or the Sailing Instructions (SI).
- 1.2 The regulations of the Caribbean Sailing Association (CSA), the CSA Minimum Safety Requirements, the International J-24 Class Association (IJCA) Rules as modified by the Caribbean J-24 Class Association, the IC-24 class Rules and the Puerto Rico Sailing Federation's Environmental Protocol will apply, except as modified, altered or made inoperative by the NOR or the SI, to the extent permitted by such rules.
- 1.3 The regatta will use two handicap systems. The CSA handicap system will be used for the CSA Spinnaker Racing Class and any other class that wish to race under this system. Only boats with an official 2015 CSA Certificate will be allowed to race in CSA Classes. Boats racing on PHRF Classes (PHRF Jib & Main and RAYA) will use the SE Florida 2016 PHRF handicap system. Only boats with an official 2016 US PHRF of SE Florida certificate will be allowed to race in PHRF classes. Certificates may be obtained at [www.phrfsef.com](http://www.phrfsef.com).

### 2. ADVERTISING

- 2.1 ISAF regulation 20.4 applies. Boats may be required to display advertising chosen and supplied by the Organizing Authority (OA) in all or any of the races, if applicable.

### 3. ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all boats with a minimum LOA of 19 feet.
- 3.2 The following divisions are expected.

Melges 32	CSA Spinnaker
PHRF Jib & Main	J-24
IC-24	RAYA
Hunter 21' 6"	Mariner 19'

- 3.3 Eligible boats may enter by completing registration with the regatta committee.

- 3.4 The Regatta Committee will determine the number of classes within a division or the number of divisions according to the number of entrants.
- 3.4.1 Jib & Main Class participants shall use only sails, which were declared as part of their sail inventory when obtaining the PHRF certificate. Only one headsail shall be used at any time and spinnakers, bloopers, or specialized sails will not be allowed. (Specialized sails are any sail flown free and not hanked on). The Regatta Committee reserves the right to accept or reject entries in the Jib & Main class as they deem appropriate.
- 3.4.2 **Classes:** The acceptance of boats in a specific class is entirely at the discretion of the Regatta Committee. Classes will generally be arranged according to rating and will be announced at the Skippers Meeting.
- 3.4.3 **Crew:** Minimum crew in all classes shall be as stated in SI 3.4.4. Maximum crew shall be in accordance to the CSA Caribbean Rating Rule. A list of crewmembers and their weights shall be filled out and turned in by the Skipper before the Skippers Meeting. No crew may be omitted, or substituted, unless permission is received in advance from the Race Committee Chairman. All requests must be submitted in writing.
- 3.4.4 **Minimum crew for all classes shall be as follows:**

- 3.5 A minimum of 3 boats is required to constitute a class.
- 3.6 The Race Committee reserves the right to waive eligibility to vessels in order to allow fair and maximum participation.
- 3.7 Boat owners shall be active members of its Class Associations (RRS 75.2). If you are not a current member of a class, membership to the appropriate association will be available at registration for a nominal fee.

#### 4. REGISTRATION

- 4.1 Registration SHOULD be done using the Yacht Scoring Program no later than Friday, June 10<sup>th</sup> at noon.

- 4.3 For a registration to be completed it must be paid in full by the deadlines indicated, otherwise the registration will be considered incomplete. The rate to be paid will be based on the date final payment is received.

## **6. SCHEDULE**

### **6.1 Skippers check in and Late Registration:**

6.1.1 At Captain's Lounge, on Friday, June 10<sup>th</sup>, 2016, from 1700 hrs. to 1930 hrs. Competitors shall register at the Registration Desk.

6.1.2 All competitors must complete registration, which includes proper completion, execution, and delivery of the "Waiver Form" to the Captain's Lounge, by 1930 hrs. on Friday June 10<sup>th</sup>, 2016. The "Waiver Form" is available under the Documents & Forms link in the Yacht Scoring.

### **6.2 Skippers Meeting**

6.2.1 The Skippers Meeting will be held in the Regatta Headquarter (BIG TENT) at 2000 hrs. on Friday, June 10<sup>th</sup>, 2016.

### **6.3 Races**

6.3.1 Races will be back to back with the first schedule warning signal at 1100 hours Saturday and Sunday.

6.3.2 No warning signal will be hoisted after 1600 hrs. on Saturday and after 1400 hrs. on Sunday.

## **7. SAILING INSTRUCTIONS**

## **8. RACING AREA**

8.1 The Race will take place in the navigational waters adjacent to Bahia Demajagua.

8.2 Navigation Charts: All yachts are encouraged to carry on board a current copy of NOAA charts # 25650 and 25663.

## **9. SCORING**

9.1 A minimum of one (1) race will constitute a regatta.

9.2 When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

9.3 When from five (5) to ten (10) races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9.4 In the event that more than ten (10) races have been completed, a boat's series score will be the total of her race scores excluding her two (2) worst scores.

## **10. SHORE FACILITIES**

10.1 Puerto Del Rey will provide free slip space for 10 consecutive days which includes two racing days for all competitors' boats that are not current clients of PDR. Utilities not included.

10.2 Racers must make prior coordination with Puerto Del Rey Marina's Dry Stack Office to reserve time and date of launching and hauling out their boats.

- 10.3 All competitors' boats using Puerto Del Rey launching facilities are urged to launch their vessel between 08:00 and 17:00 hours on Friday, June 10 and Saturday June 11, 2016 free of charge. Fees will apply if launched outside of that schedule.
- 10.4 Vessels launched from 17:00 to 18:00 will be charged \$5.00 p/f. No launching service will be provided for competitors after 18:00.
- 10.5 Based on safety concerns, medium centerboard boats such as O'Days 19, J-70 or others that requires the use of Dry Stack Ramp, may not use the finger or the travel lift.
- 10.6 All competitors using Puerto Del Rey haul-out facilities on Sunday, June 12, 2016 will be hauled-out free of charge before 17:00 hours. No service will be provided after 17:00 hours. Vessels will remain in the water until next day and should be retrieved on Monday June 13, 2016 before 12:00PM. This applies to vessels with and without contract. Vessels without contract will pay \$5.00 p/f at the Marina Customer Service Office.
- 10.7 Boat washing cannot be performed in the Dry Stack area, it will only be permitted at the boatyard known as the "15 Cuerdas".
- 10.8 DINGHY RACEBOATS (EXCEPT HC 16, 420, Snipe or boats requiring the use of the Dry Stack Ramp) Will launch boats through the floating dock located in the proximity of Dock 85 at Puerto Del Rey. Overnight space and security will be provided in that area for Friday and Saturday night.
- 10.9 Mother Ships: Currently there are only 10 docks available for mother ships which will be reserved on a "first come first serve" basis. Only one mother ship per competing vessel will enjoy this benefit. In order to reserve a slip you must contact Captain Jose M. Albiñana at (787) 413-0299 or at josemariaalbinana@yahoo.com at least 7 days before estimated date of arrival. A reservation number will be issued and will be needed in order to fill out the Vessel Boat Space License Agreement at the Marina.
- 10.10 No trailers will be permitted in the parking areas of the Marina.

## **11. PRIZES**

- 11.1 Class trophies will be awarded to the first 3 places in each class.
- 11.2 Additionally cash prizes will be distributed to the participating classes. Detail will be provided at a later date.

## **12. CUSTOMS AND IMMIGRATION**

- 12.1 Service is available Monday through Saturday from 0800 to 1630 hours at the ports of entry in San Juan, Fajardo, Ponce, Mayagüez, Vieques, and Culebra. USA registered boats not carrying aliens on board may clear customs by phone. Be aware that when clearing customs by phone, ONLY THE SKIPPER is permitted off the yacht while the procedure is being completed. A violation of the procedure could result in severe penalties.
- 12.2 Aliens must clear Immigration before entering. A new requirement for non-U.S. citizens wanting to gain entry to the U.S. by way of a non-commercial vessel--for example a private sailboat--is that he or she must have a visa.
- 12.3 There will be no special services of Customs or Immigration at the marina.

### **13. DISCLAIMER OF LIABILITY**

13.1 Competitors agree to be bound by the International Sailing Federation Racing Rules of Sailing (RRS), by the Sailing Instructions and the Notice of Race. Competitors agree to take any and all responsibility for the nautical qualities of their vessels, the rigging, the crew's ability and the safety equipment. Competitors also agree to take any and all responsibility for damages caused to third persons (bodily injury included but not limited thereto) or their belongings, to themselves (bodily injury included but not limited thereto) or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility The Federación de Vela de Puerto Rico Organization, Puerto Del Rey Marina, and all persons involved in the organization under whatever qualification. Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that The Federación de Vela de Puerto Rico Organization, the sponsors and their agents, have no responsibility for loss of life or injury to members or others or for the loss of, or damage to any vessel or property. As part of the registration process, each individual participating crewmember will be required to sign a declaration accepting this disclaimer of liability.

### **14. INSURANCE**

14.1 Each participating boat shall be insured with valid third-party liability insurance company whose rating by A.M. BEST is not less than A-.
