### **NOTICE OF RACE**

#### **1 RULES**

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Boats shall observe the current Minimum Equipment Recommendations of YRA of LIS, Race Category C. However section 2, Structural Features, does not apply to boats not designed and equipped with pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 The sailing instructions will state that rule V1, Penalty at the Time of an Incident, will apply.
- 1.5 Appendix T will apply as changed below:  
At the end of T4, Arbitration Meeting Outcomes, add: (c) If a protest is not withdrawn after arbitration, the arbitrator will not be a member of the jury that hears that protest but will be permitted to observe the testimony presented and offer evidence. This changes rule 63.3(a).

#### **2 ELIGIBILITY AND ENTRIES**

- 2.1 The regatta is open to IRC, PHRF, Offshore One Design Racer/Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes.
- 2.2 Eligible boats may enter by registering online at Yacht Scoring: <http://www.yachtscoring.com> and submitted no later than 1700, Wednesday, July 12, 2017.
- 2.3 The Entry Fee is \$100.00 which includes after sailing lawn parties, awards ceremony and guest moorings on a first come basis. See the Social Calendar for details
- 2.4 For those classes not sailing One-Design, entries shall be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS.
- 2.5 For boats racing PHRF or IRC, any weight credit/limit listed on the PHRF or IRC certificate will be waived. There will not be a minimum or maximum weight limit in effect for any PHRF or IRC boat.

#### **3 SCHEDULE, COURSES AND RACING AREA**

- 3.1 The racing area will be in the waters off Larchmont Harbor.
- 3.2 The first warning will be at 1255 each day.

Sat July 15	Windward-leeward with multiple races at the discretion of the race committee Non Spinnaker boats will race a single navigator course
Sun July 16	A single Pursuit Race

Courses will be as described in the sailing instructions.

#### **4 SAILING INSTRUCTIONS**

- 4.1 Sailing instructions will be available no later than 1800 July 7 and posted online at: [www.larchmontyc.org](http://www.larchmontyc.org) and <http://www.yachtscoring.com> or the Hospitality Desk on the day of the event.
- 4.2 Scratch sheets will be available online as listed above no later than 1800 Friday, July 14 or the Hospitality Desk during the event.

#### **5 SCORING**

- 5.1 One completed race constitutes a series.

- 5.2 A boat's series score will be the total of her race scores without exclusion.  
5.3 For PHRF, time allowances will be computed using Time on Distance. For IRC the boats rating allowance will be applied as a factor of the elapsed time.

## **6 PRIZES**

- 6.1 Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 23 following the completion of racing on the front lawn of the Larchmont Yacht Club.  
6.3 Perpetual trophies will be awarded at the discretion of the race committee, fastest elapsed time in the Execution Rocks Race, and fastest corrected time in the Execution Rocks Race.  
6.4 The team that sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The current elapsed time record is 43 minutes 57 seconds, set by yacht ELVIS on 19 July 2015.  
6.5 This regatta is a qualifying event for the YRA Youth Challenge Cup, the Sally Finkbeiner Trophy, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.

### 2 ELIGIBILITY

- 2.1 The regatta is open to the following one-design classes: J/105, Viper 640, Etchells, J/70, IOD, Shields, S-Boat, Ideal 18, K6 or any other one-design class that qualifies. To qualify as a class for this regatta, three valid entries must be received for that class prior to 1800, Wednesday, July 12.
- 2.2 If a class elects to race on a single weekend, the Class Fleet Captain shall notify the race committee no later than Weds. July 12. On days when that class elects not to race, boats in that class will not be given a start, nor will they be scored.

### 3 ENTRIES

- 3.1 Eligible boats may enter by completing the online entry at: <http://www.yachtscoring.com>. Entries must be submitted no later than 1200 on Friday, July 14.
- 3.2 The entry fee is \$100.00 per boat. For classes electing to race one weekend the entry fee is \$75.00. The Entry Fee includes after sailing lawn parties, awards ceremony and guest moorings on a first come basis.

### 4 SCHEDULE

- 4.1 The first warning signal will be at 1225 each day.
- 4.2 The race committee intends to run multiple races each day.

### 5 SAILING INSTRUCTIONS

#### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Non-inflatable, Coast Guard-approved personal flotation must be worn by skipper and crew at all times while on the water, except briefly while changing or adjusting clothing or personal equipment. This changes rule 40 and the preamble to the Part 4 rules.
- 1.3 The sailing instructions will state that rule V1, Penalty at the Time of an Incident, will apply.
- 1.4 Appendix T will apply as changed below:  
At the end of T4, Arbitration Meeting Outcomes, add: (c) If a protest is not withdrawn after arbitration, the arbitrator will not be a member of the jury that hears that protest but will be permitted to observe the testimony presented and offer evidence. This changes rule 63.3(a).
- 1.5 Class Rule 4.2 is amended to permit the use of non-builder sails; however boats must declare their use at registration. A boat or equipment may be inspected at any time for compliance with class rules.
- 1.6 Boats may be required to display bow numbers provided by the organizing authority.

#### 2 ENTRIES & FEES

- 2.1 The regatta is open to all boats of the Vanguard 15 one-design class.
- 2.2 All eligible boats may enter by submitting an online entry not later than 0900 Saturday, July 22, 2017 at: <http://www.yachtscoring.com>.
