Sailing Instruction Amendment No. 1

1. CLASS BREAKS & STARTING TIMES

2. THE COURSE

2.1. After Starting, all yachts shall round Four Mile Crib leaving it to **STARBOARD** and then continue to the turning mark near Michigan City. The turning mark will be a yellow tetrahedron at approximate Latitude N 41 44.30 and Longitude W 86 56.00. While approaching the turning mark be aware that a RC boat may be anchored approximately 0.25 nm to the east. The turning mark shall be left to **STARBOARD**. After rounding the Michigan City turning mark, yachts shall continue to Indiana Shoal Gong Buoy "4" laying it to **STARBOARD** and then onto Chicago Lake Front Northeast Shoal Lighted Buoy "2", laying it to **STARBOARD**. Yachts shall then continue to the Four Mile Crib, which this time shall be laid to **PORT**. The fi. The finish will be in the same location as the start.

2.2. The Table below summarizes all marks of the course, their order and their approximate locations.

3. THE FINISH

Columbia Yacht Club

- 3.1. When approximately one mile from the finish, each boat shall notify the race committee on Channel 78. Sail number boards shall be displayed on the Starboard side at the finish.
- 3.2. Each boat must turn in a Finish report to the Columbia RC, not later than 2000 hours (CDT) on 7/1/2017. Boats shall submit their finish report to racemgt@colyc.org as soon as practical after finishing or before 2000.
- 3.3. Finish reports must include; boat name, owner name, owner cell phone number, finish time, if possible names of the boat finishing ahead and behind.
- 3.4. Boats may also dock at Columbia Yacht Club while submitting the Finish Report to the main office.
- 3.5. In the event of inclement weather, the RC reserves the right to set an alternate Finish Line and/or location. **In such case, the RC shall broadcast changes on Channel 78 starting after 2400 hours (CDT) with approximately 30-minute subsequent intervals.** Whenever a RC boat is not on station at the finish line, finishing yachts shall follow the procedure outlined in the US Sailing prescription to RRS 34 as modified. The last sentence of the US Sailing prescription to RRS 34 is modified to read:
"If a boat finishes when race committee is absent, to be scored as finishing she shall
 1. *Note her finishing time. The finish time shall be the GPS CDT time when the alternate finish line is crossed.*
 2. *Notify the RC, on Channel 78, of their finish time (GPS CDT time) as soon as practical after finishing".*

4. TIME LIMIT

The time limit shall be 1600 CDT on 7/1/2017, plus the amount of any postponement time applicable to a class start. This changes RRS 35.

5. DOCKAGE

Rafting privileges extended to entered boats at Columbia Yacht Club prior to race. Food, ice, and beverage services will be available. After finishing, yachts can dock at Columbia at no charge while submitting their Finishing Reports and/or having breakfast at the club.

6. SOCIAL ACTIVITIES

Columbia YC dining room opens 0900 Saturday 7/1/2017. The first three boats ordering breakfast/brunch at the club will receive a complimentary bottle of bubbly.
