Notice of Race

1. ORGANIZING AUTHORITY

1.1. Columbia Yacht Club is the Organizing Authority for the 3 Crib Fiasco, hosted by Skyway Yacht Works.

2. RULES

- 2.1. The regatta will be governed by rules as defined in the Racing Rules of Sailing (RRS).
2.2. Images from a drone vehicle is not admissible as evidence in a protest or redress hearing.

3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to all sailboats 20ft or longer; that is equipped with a GPS and VHF radio capable of broadcasting and receiving on VHF channel 69, meet US Coast Guard safety requirements, as well as US Sailing nearshore requirements.
3.2. All boats must register by Wednesday **September 19, 2018**, online at www.yachtscoring.com.
3.3. Assignment of 3 Crib Fiasco handicaps is offered as an accommodation and such handicaps are not subject to competitor review or protest.
3.4. Boats that do not have a Lake Michigan Performance Handicap Racing Fleet (LMPHRF) certificate or will be racing in a configuration different from that declared for the LMPHRF certificate SHALL apply for a rating by submitting a rating application to the Columbia Yacht Club Office no later than **September 19, 2018**, at 1700.

4. **FEE:** The entry fee is \$95.

5. SCHEDULE OF EVENTS

- 5.1. Saturday **September 22** 1800 Pre-race party
Sunday **September 23** 1100 First Warning
1600 Regatta party on Aft Deck and awards

5.2. This will be a Pursuit Race, competitors starting time will be providing on www.yachtscoring.com no later than **September 23, 2018**, at 0900.

6. SAILING INSTRUCTIONS

The sailing instructions will be available after 1700 on **September 22, 2018**, at www.yachtscoring.com.

7. VENUE

The course will be sailing around the three Chicago Cribs in either direction.

8. SCORING

Boats will be scored in order of finishing place, as the starting times account for handicaps.

9. PRIZES

Prizes will be awarded to first through third during the regatta party.

10. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

11. CONSENT

Competitors consent to the use by organizing authority of their name, image, photo, voice or visual recordings of their images (“Recordings”), or any statements, whether oral or written, regarding the regatta (“Statements”) and for the organizing authority to use, sell, copy, distribute, perform, display, transmit, or otherwise, exploit the foregoing Recordings, Statements and personal identifiers by any means and in any media known or hereafter devised. Competitors waive any rights of privacy or publicity in connection with the use of their name, Recordings or Statements waive the right to credit or acknowledgement in conjunction with their identity, Recordings or Statements and acknowledge that they shall have no right to inspect or approve any use of their identity, Recordings or Statements.
