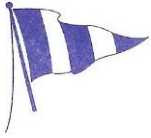

#### **NOTICE OF REGATTA**

##### **1 RULES**

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*, the current IRC Rules, the current PHRF Regulations as administered by the YRA of LIS and Level or One-Design Class rules
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

##### **2 ENTRIES**

- 2.1 Eligible boats may enter by registering on line at Yacht Scoring: [www.yachtscoring.com](http://www.yachtscoring.com) or on approved entry forms received by the Larchmont Yacht Club front desk not later than 1700, Wednesday, July 13, 2011
- 2.2 The Entry Fee is \$100.00.
- 2.3 There will be IRC, Level, Classic, One Design and PHRF divisions. At the discretion of the race committee separate divisions for Level and One-Design may be assigned. Divisions may be subdivided into classes.
- 2.3(a) For those classes not sailing Level or One Design, entries must be accompanied by a valid PHRF, IRC or CRF rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS. IRC certificates do not need to be endorsed. CRF ratings will be entered as sec/mile.

##### **3 SAILING INSTRUCTIONS**

- 3.1 Sailing Instructions will be available at least one week before the regatta on the internet at: [www.larchmontyc.org](http://www.larchmontyc.org) and [www.yachtscoring.com](http://www.yachtscoring.com) or at the Larchmont Yacht Club front desk or the Hospitality Desk on the day of the event. Sailing instructions may also be available on the first day of racing prior to the first warning signal of the day from the committee boat.
- 3.2 Scratch Sheets will be available at the front desk after 1800 Friday, July 15, at the Hospitality Desk during the event and, and from the committee boat prior to the first warning signal of the day or on line at Regatta Manager.

##### **4 COURSES, RACING AREA AND RACES**

- 4.1 The racing area will be south of Milton Point.
- 4.2 The courses will be as described in the Sailing Instructions.
- 4.3 The warning for the first division will be at 1055 each day.

## **5 SCORING**

- 5.1 One completed race constitutes a series.
- 5.2 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).
- 5.3 For PHRF and CRF time allowances will be computed using Time on Distance.  
For IRC the boats rating allowance will be applied as a factor of the elapsed time.

## **6 PRIZES**

Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 24 after racing on the front lawn of the Larchmont Yacht Club.

## **7 GUEST MOORINGS AND CLUB PRIVILEGES**

- 7.1 Guest moorings will be available on a first come basis at no charge. Reservations are required. Please contact the Waterfront Director, Lincoln White, at 914-468-7742 or email [moorings@larchmontyc.org](mailto:moorings@larchmontyc.org) for reservations.
- 7.2 The privileges of the Club for Race Week will be extended to owners and crews.

##### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*.
- 1.2 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

##### 2 CLASSES

- 2.1 The regatta is open to the following one-design classes: Viper, E-22, I.O.D, Shields, Sonar, S Boats, 505, and RK6. To qualify as a class for this regatta, 3 valid entries must be received for that class prior to 1800, Wednesday, July 13.
- 2.2 A class may elect to race on one weekend instead of the two that are scheduled. On days when a class elects not to race, boats in that class will not get a start, nor will they be scored, provided that the race committee has been previously informed of such class decision.

##### 3 ENTRIES

- 3.1 Eligible boats may enter by registering on approved entry forms sent by mail or fax OR online at: [www.yachtscoring.com](http://www.yachtscoring.com) or [www.larchmontyc.org](http://www.larchmontyc.org) and received at the Larchmont Yacht Club front desk not later than 1200 Friday, July, 15, 2011
- 3.2 The entry fee is \$100.00 per boat. For classes electing to race one weekend the entry fee is \$75.00.
- 3.3 All entries not submitted on line, shall be mailed or faxed to the Larchmont Yacht Club, 1 Woodbine Ave., Larchmont, NY 10538. Telephone: 914-834-2440. Faxed entries will be accepted only with a valid signature for credit card authorization. Fax: 914-468-7751. All entries must be signed by the owner or master. Credit card authorizations must be legible and signed by the card holder.

##### 4 SAILING INSTRUCTIONS

The 2011 YRALIS Mid-Sound One-Design Sailing Instructions will apply. - 7.2 Series prizes will be awarded for classes that qualify under section 2.  
First place for all classes with three or more competitors.  
Second place for all classes with four or more competitors.  
Third place for classes with five or more competitors.
