



# American Yacht Club Friday Night Sunset Series

**May 25 to August 10, 2018**

## NOTICE OF REGATTA

**RULES:** The regatta will be governed by the rules as defined in the Racing Rules of Sailing, including the US Sailing Prescriptions; the current PHRF regulations, as administered by the YRA of Long Island Sound (YRALIS); and the Minimum Equipment Recommendations of the YRALIS (Category C); except as any of these are changed by this Notice of Race and by the Sailing Instructions.

**ELIGIBILITY:** The regatta is open to yachts captained by members of American Yacht Club and local J70 sailors. **Each owner must have a current PHRF certificate from the YRA.** Weight and crew limits as pertaining to PHRF certificates will be waived for the series. **ENTRIES:** The entry form and entry fee of \$85.00 must be received by the American Yacht Club by 1900 on Thursday, May 24th. Entries can either be faxed (914-967-5340) or entered electronically through [Yachtscoring.com](http://Yachtscoring.com). A copy of each yacht's PHRF certificate must also be submitted. Late entries may be received but depending on the timing, may not be eligible to be scored in the series.

**SCHEDULE:** One race is scheduled for each Friday evening from May 25th to August 10th. The fleet will be divided into divisions at the discretion of the race committee. There will also be a separate start for the J70 class.

On Friday, June 1 an overnight race will be held to compete for the John B. Shethar Trophy. Participation in this event will count toward qualification for the Sunset Series, but will be scored as a separate event.

**START TIME:** The first warning signal will be made at 1855.

**SAILING INSTRUCTIONS:** Sailing Instructions will be posted on the American Yacht Club website, [www.americanyachtclub.org](http://www.americanyachtclub.org) and also on [Yachtscoring.com](http://Yachtscoring.com).

**RACING AREA:** The racing area will be in the vicinity of Bell 42. It is expected that the starting line will be located within one mile of Bell 42.

**THE COURSE:** The course to be sailed will be around government and inflatable marks.

**NOTICES:** Notices, including notices that may amend the Notice of Regatta or the Sailing Instructions, will be posted on the Race Committee Notice Board and on [Yachtscoring.com](http://Yachtscoring.com).

**EQUIPMENT:** Boats shall observe the Minimum Equipment Recommendations of the YRALIS, Race Category C. Each boat shall carry a radio capable of transmitting and receiving VHF 71 as well as channel 16.

Spinnakers shall not be used except on the June 1 John B. Shethar Trophy Overnight Race. For regular Friday Night Sunset Series racing, boats shall not perform sail changes except in the case of serious damage to the sail.

**SCORING:** In order to be eligible for series prizes, a boat must start in at least 50% of the races that are completed. The Cox-Sprague Scoring System as published by the YRALIS will apply. Boats will be scored using the PHRF handicaps provided by the YRALIS and course distance. Throw out races will apply depending on participation.

**PRIZES:** Weekly prizes will be awarded at AYC after each race. The Scotch Caps Trophy will be awarded at the Club's annual awards dinner to the boat with the best series percentage score. The Michael Duncan Memorial Trophy will be given to the boat with best participation, improvement and sportsmanship.
