Etchells Fall Championship | September 28 & 29 | Shelter Island, NY

1. VENUE / AUTHORITY

- 1.1 Shelter Island Yacht Club invites all members and associates of the International Etchells class to the Etchells Fall Championship.
- 1.2 SIYC/Fleet 15 is the organizing authority and the host for the regatta. The regatta will be sailed on the waters around Shelter Island, NY.
- 1.3 The regatta will be managed by the Regatta Committees of SIYC/Fleet 15.

2. RULES:

- 2.1 The Regatta will be governed by the "Rules" as defined in the Current Racing Rules of Sailing (2017-2020 RRS) and the International Etchells Class Rules.
- 2.2 All Prescriptions of US Sailing will apply.
- 2.3 All Skippers are required to be current members of the International Etchells Class Association and crew are required to be associate members.
- 2.4 The Organizing Authority may require all participating boats to display the event sponsor's advertising in accordance with ISAF Regulation 20.3. (d) (i).
- 2.5 The International Etchells Class Rules are changed as follows: All competing boats shall carry a hand held VHF radio for safety purposes, and Race Committee communications.
- 2.6 All additional information related to the Etchells Fall Championship will be available at www.yachtscoring.com.

3. ELIGIBILITY AND ENTRY:

- 3.1 The Regatta is open to all boats of the International Etchells Class.

4. ENTRY FEES:

- 4.1 The entry fee for the Etchells Fall Championship is \$225.
- 4.2 All boats must complete the Entry Forms found on the Yacht Scoring Website by 1800 Friday September 27th.

5. SCHEDULE OF EVENTS:

6. MEASUREMENT:

6.1 All yachts and crew will be required to conform with rules of the International Etchells Class Association.

7. SAILING INSTRUCTIONS:

7.1 The SIs for the Etchells Fall Championship will be available on www.yachtscoring.com, and at the skippers meeting.

8. HAUL-OUT RESTRICTIONS:

8.1 No boat shall be hauled out during the regatta except with and according to the terms of prior written permission of the event PRO.

9. COURSES:

9.1 The courses will be Windward–Leeward. Windward offset marks and leeward gate marks may be used.

10. SCORING:

10.1 The Low Point Scoring System as described in Appendix “A” of the RRS will apply, except that if more than 5 races are completed a boat may exclude her worst score.

11. PRIZES:

11.1 Prizes will be awarded to the top three boats.

12. SUPPORT BOATS:

12.1 Support boats shall register with the Race Committee prior to the Skippers Meeting. Support boats will be given an identifying flag and assigned a number. The identifying flag shall be flown at all times during the regatta and all support boats are required to monitor and comply with instructions given on VHF 72 during the regatta.

13. TEMPORARY REGATTA BOAT STORAGE:

15. DISCLAIMER OF LIABILITY:

By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

16. MANDATORY INSURANCE:

16.1 Each boat is required to hold adequate insurance including third-party liability insurance, and it is the owner or owners' representative's sole and inescapable responsibility to ensure that the insurance is in place and is adequate prior to participating in this event. **Proof of insurance will be required.**
