

**NOTICE OF RACE**  
**DINGHY'S WHIDBEY ISLAND 2013**  
**Part of Whidbey Island Race Week 2013**  
**One Design Dinghy & Catamaran Racing**  
**July 13-14<sup>th</sup>, 2013**

**MANAGEMENT** Dinghy's Whidbey Island will be conducted by Clear Ahead Marine Productions which will have the authority to reject any entry before each race starts; interpret the rules and conditions of the race; and decide any protests. The fleet shall be one design classes according to size and other factors at the discretion of Clear Ahead Marine Productions

**RULES** The rules governing Dinghy's Whidbey Island 2013 will be:

- A. The regatta will be governed by the current rules as defined in The Racing Rules of Sailing (RRS) 2013-2016.
- B. This Race Notice, and The Sailing Instructions, including any amendments
- C. US Sailing Prescription to RRS 64.3 (b) will not apply
- D. In the case of a conflict between this NOR and the Sailing Instructions, the Sailing Instructions shall prevail.

**CONDITIONS OF ENTRY** Entries will be restricted to Dinghies, small monohull's and Catamarans

**HANDICAPPING** To qualify for fleet scoring, four class boats must be registered. One Design Classes with fewer than four registered by the deadline will be grouped into a Open Fleet and will be scored using the 2013 Table of the North American Portsmouth Handicap.

**ENTRY LIMITS** 250 boats (Dinghy's and Catamarans combined).

Each boat is required to have a valid Certificate of Measurement as appropriate to its class, and must sail under its class registration number.

**INSURANCE** Each competing boat must be insured.

**EQUIPMENT** Every boat must be in a seaworthy condition.

**PERSONAL BUOYANCY** All helmsmen and crew must wear adequate personal buoyancy equipment. Wet suits will not be deemed as buoyancy equipment. **LIFEJACKETS ARE REQUIRED TO BE WORN.**

**CREWS COMPETENCE** Patrol boats will be in attendance. Both the helmsmen and crew must be sufficiently experienced to recover after a capsized and be able to sail on unless vital gear is broken.

**AWARDS** Will be passed out at Sunday's Award Ceremony/Party.

Fleets with 4-6 Starters    2 Awards

Fleets with 7-10 Starters    3 Awards

Fleets with 10+ Starters    4 Awards

**IDENTIFICATION.**

DWI is part of Whidbey Island Race Week Identification will be required for each person participating in any of the many DWI/ Race Week activities. Additional guest Identifications will be available at DWI/ Race Week Headquarters for \$25.

**REGISTRATION INCLUDES**

Registration includes the Saturday night dinner(barbeque) and beverages. Sunday- Entertainment and beverages. Extra tickets are available below.

**Friday, July 12<sup>th</sup> Registration 1500-2000:** Distribution of Identifications, Race Kits, Entry List and Special Instructions

**Saturday, July 13<sup>th</sup> Registration 0800-1000:** Distribution of Identifications, Race Kits, Entry List and Special Instructions

**Saturday, July 13<sup>th</sup>** Racing starts at 1200 Up to 10 starts

**Saturday-Party:** Starting one hour after the last finisher has finished or 1800. Free Barbeque Dinner for participants.

**Sunday, July 14<sup>th</sup>** – Racing Starts at 1200 Up to 6 starts

**Sunday, July 14<sup>th</sup>** – Awards Party will be at 1800-2000 Event ID's will have a cross over to the party for Whidbey Island Race Week 2013. Awards to be presented as close to 1900 hours as possible.

**ENTRY PROCEDURE** please complete and mail an Entry Form and fees as soon as possible. An acknowledgment will be e-mailed to each entrant shortly after entry receipt.

- A. DWI Program, including Sailing Instructions, will be presented to each accepted entry at registration
- B. The regatta will be limited to the first 250 combined entries. NO ENTRIES WILL BE ACCEPTED AFTER THIS LIMIT IS REACHED.
- C. Entry closing will be July 10, 2013 or when the Limit has been reached.
- D. By submitting an entry each owner/skipper certifies that they have read and accept the Conditions of Dinghy's Whidbey Island (DWI).

Each Skipper and his crew must evaluate weather and sea conditions and each participant is responsible for determining whether it is safe for him to participate. The responsibility of wearing a life jacket rests upon the Skipper and his crew. Life Jackets are required to be worn. If Committee vessels and personnel provide assistance, it is at the risk of the participants.

I hereby agree to all of the Conditions for Dinghy's Whidbey Island 2012 and shall inform each member of my crew of these Conditions. I hereby warrant that my yacht will be outfitted, equipped and handled in accordance with these Conditions; that she will have all of the required equipment aboard; that she is seaworthy in hull, rig and gear; that she will be completely manned. I agree that the rating with my entry as filed with the Committee will be the applicable rating for the yacht at the time she starts the race.
