NOTICE OF RACE

ORGANIZING AUTHORITY: Nyack Boat Club, Nyack, NY

1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Appendix V will apply.

2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all boats of the Lightning, Sonar, and Viper classes.
- 2.2 Registration is available online at <https://yachtscoring.com/emenue.cfm?eID=9496>
All fees must be paid and waiver signed online prior to June 14, 2400 hrs.

3 FEE

Fee is \$100.00 per boat for Lightnings and Vipers, and \$135 for Sonars, and include coffees, juice & bagels breakfasts, lunch Saturday & Sunday, hospitality after racing on both days, as well as dinner & music for skippers and crews on Saturday -- bigger party, more fun! Extra dinners can be purchased separately during registration.

6 VENUE

Races will be sailed in the Tappan Zee of the Hudson River.

8 SCORING

- 8.1 One race completed constitutes a regatta for each fleet.

8.2 If 6 or more races are sailed, a boat's worst score shall be excluded.

9 RADIO COMMUNICATION

The Race Committee intends to use VHF to make announcements to competitors on the water. No broadcast communication from the competitors is allowed except for safety reasons or withdrawing from the race.

10 PRIZES

Trophies will be awarded to the top three skippers and crews in each Fleet.

11 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. Sailing is an activity that has an inherent risk of damage and injury. The Organizing Authority, any Sponsors, Support Facilities, Volunteers, Agents, Employees and Service providers, the PRO, and the Committee will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after the Regatta for both on the water and on land activities. By participating in this event, each competitor (owners, skippers, and crew) agrees to release the race organizers and all persons and groups listed above from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
